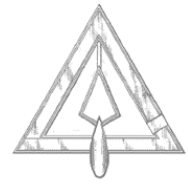

## METHOD OF ISH SODI POINT ACQUISITION (ARIZONA)

- A) Each Companion receiving the ISH SODI Award **must** be the top-line signer of at least one new **greeted** Council member during the current award year and attain no less than ten points during the award year.
- B) Application for the Ish Sodi Award shall be made to the Grand Council of Cryptic Masons of Arizona through the Grand Recorder's Office on the approved petition form. The Applicant **MUST** have his Petition certified by his Constituent Council Recorder and sent into the Grand Recorder's office. Applicant **MUST** be physically present to receive the award. Awards do not carry over to the next year if applicant is unable to attend.
- C) Points are accrued in the following ways:
- 1) (3 points EACH) Being the top-line signer of a new Council member (Three new members totals 9 points).
  - 2) (2 points) One hundred percent attendance at 10 meetings (scheduled business and degree, including authorized joint or unified business Assemblies) of the local Council. If an excused absence is required, it must be requested and approved from one of the dais officers of the local Council before the meeting in question is held, in order to be credited as attendance.
  - 3) (1 point) Doing or assisting in Council degree work in the year.
  - 4) (1 point EACH, not to exceed 3 points) Giving assistance to a local Symbolic Lodge in any capacity during the year.
  - 5) (1 point) Serving as an elected or appointed Council Officer of his local Council for the year. Multiple Council elections or appointments are not eligible to accumulate points. A local Council is defined as the Council that is designated by the certification of the Constituent recorder on this form. Additionally, only one officer station will be counted that the officer is serving.
  - 6) (1 point) Donating in any aggregate amount to the Cryptic Masons Medical Research Foundation.
  - 7) (1 point) Attending the Annual Assembly of the Grand Council of your Jurisdiction. If your jurisdiction did a virtual Grand Session will count.
  - 8) (1 point) Visitation to 3 different Councils within your Jurisdiction during the year.
  - 9) (2 points) Visitation to all of the Councils within your Jurisdiction during the Arizona Cryptic year.
  - 10) (1 point EACH, not to exceed 3 points) Assisting with a Masonic project, such as a pancake breakfast, open to the general public in the name of Masonry. (Note: Masonic Youth Group projects will be credited toward this category.)
- D) **Other Jurisdictions:**
- 1) Awards to foreign jurisdictions must be approved by the Most Illustrious Grand Master of the Grand Council of Cryptic Masons of Arizona.
  - 2) The awards are only available to those attending the Arizona ceremonial conducted by the Most Illustrious Grand Master of Arizona or his assigned Arizona Grand Council officer.
  - 3) All petitions from your Grand Council shall be Certified by the Grand Recorder (local recorders should verify, but the Grand Recorder must Certify).
